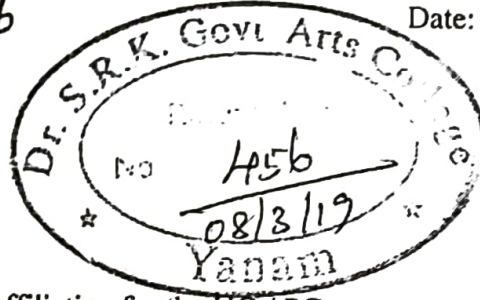

I am to communicate the following observations / conditions of the Inspection Committee that visited your college viz. Dr. S.R.K. Government Arts College, Yanam on 11.02.2019 in connection with your request for continuation of provisional affiliation for the UG/PG courses and starting of New PG course viz M.Sc. Chemistry for the academic year 2019-20.

The Inspection Committee has recommended continuation of provisional affiliation for the following UG/PG courses and Provisional Affiliation for the New PG course viz M.Sc. Chemistry with the intake noted against each for the academic year 2019-20, subject to fulfilling the conditions noted below and rectification of deficiencies:-

New Course recommended for Provisional Affiliation – 2019-20.

Sl. No	Name of the Course	Intake
1.	M.Sc. Chemistry	18

Observations/Conditions to be fulfilled:

1. M.Sc., Chemistry Practical laboratory should be ready before the commencement of the course.
2. Two more Faculty members should be appointed before the commencement of the course.
3. Appointment of Physical Education instructor should be made.
4. Appointment of Library Staff should be made.
5. Appointment of faculty members (2) for Physics should be made.
6. French as a third language may be introduced.
7. Library needs improvement – new books and journals should be procured. Library staff needs to be appointed.
8. Additional Computers terminals and systems should be added.
9. Residential accommodation facilities for students and staff should be provided.
10. Other facilities/amenities like sanitary, ladies room, canteen, facilities for differently abled persons, transport, Co-operative stores, book bank, medical, bank extension counter, etc. should be extended.
11. College should submit evidence for Village Adoption & Rain Water Harvesting activities.

You are requested to rectify the above deficiencies and submit a compliance report along with supporting documents / proof. You are also required to submit an Undertaking in non judicial Stamp paper to comply with all the other affiliation conditions enclosed herewith within 10 days from the date of receipt of this letter so as to consider continuation of provisional affiliation for the above courses for the academic year 2019-20.
